NOTICE INVITING BIDS

Notice is hereby given that the City of Hermosa Beach will receive electronic bids until 2:00 pm on Thursday, May 15, 2025 at which time the electronic bids will be publicly opened at the City Council Chambers at 1315 Valley Drive, Hermosa Beach, CA 90254 and posted on PlanetBids for CIP No. 114 Greenwich Village North – Underground Utilities Assessment District.

The Contractor's Bid shall be valid for a period of one hundred fifty (150) calendar days from the date the response is due.

The project includes, but is not limited to, the construction of the civil infrastructure required to underground existing overhead utilities along Hermosa Avenue, between 35th Street and 25th Street. The scope of work includes, without limitation, furnishing all necessary labor, materials, equipment and other incidental and appurtenant Work necessary to satisfactorily complete the Project, as more specifically described in the Contract Document, permits from regulatory agencies with jurisdiction, and applicable regulations. The quantity of Work to be performed and materials to be furnished are approximations only, being given as a basis for the comparison of Bids. Actual quantities of Work to be performed may vary at the discretion of the City Engineer. There will be three Notices to Proceed establishing the total time for completion of the Work as follows:

<u>Notice to Proceed No. 1 (Submittals)</u> – The time for completion to provide submittals to the City for critical path items and materials is *10 working days* from the date specified in the Notice to Proceed No. 1.

<u>Notice to Proceed No. 2 (Materials Order and Delivery)</u> – The time for completion to order the critical path item materials needed to complete the work is 10 working days from the date specified in the Notice Proceed No. 2 and an additional 40 working days is provided to receive all materials needed for a total of 50 working days to commence the work.

Notice to Proceed No. 3 (Start of Construction) – The time for completion of the total contracted work is 90 working days from the date specified in the Notice to Proceed No. 3.

The engineer's cost estimate for the project is \$2,041,000. License requirement is a valid <u>State of California Contractors License Class "A" General Engineering Contractor.</u>

All sidewalk and access ramp removals shall be replaced within 72 hours of removal. Traffic control plans are required as part of this project to maintain uninterrupted safe vehicular, bicycle, and pedestrian traffic throughout the work areas.



NOTIFICATION PAUSING ENFORCEMENT OF PW SYSTEM REQUIREMENTS - 1771.4(a)(3)

This is to notify interested parties that enforcement of contractor registration requirements as well as the requirement to submit electronic certified payroll records (eCPRs) to the Labor Commissioner using DIR's online eCPR system is temporarily paused for the period of 12 months, which runs from 6/22/2024 through 6/22/2025. Awarding Agencies will not be penalized for hiring unregistered contractors nor need to withhold funds due to a contractors inability to register nor provide eCPRs due to system issues. Additionally, Awarding Bodies and Prime Contractors should not prevent contractors from bidding or working on a Public Works jobs as a result of their inability to register or submit certified payroll due to system issues. Once the stay of enforcement is lifted, contractors will not be required to retroactively submit eCPRs nor will they be required to retroactively register. It is important to note that the requirement to submit eCPRs is separate and distinct from the obligation in Labor Code section 1776 which is unaffected by this notice. The Labor Commissioner recommends that awarding bodies and general contractors consider this announcement in the administration of their public works projects.
