**ORDINANCE NO. ORD-25-XXXX**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, AMENDING HERMOSA BEACH MUNICIPAL CODE CHAPTER 10.36 PARKING METERS, INCREASING METER RATES**

**WHEREAS**, California Vehicle Code Section 22508 *et seq.* requires the City of Hermosa Beach ("City") to establish parking meter rates by ordinance; and

**WHEREAS**, Chapter 10.36 (Parking Meters) to Title 10 (Vehicles and Traffic) of the Municipal Code ("Code") outlines the parking meter rate requirements established by the City; and

**WHEREAS**, the City wishes to amend the Code by increasing parking meter rates in order to maintain the financial viability of the City's parking program and be consistent with parking rates in comparable jurisdictions.

**THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH DOES HEREBY ORDAIN AS FOLLOWS:**

**SECTION 1.** Recitals. The recitals above are true and correct, and are hereby incorporated herein by this reference.

**SECTION 2.** Amendment. Section 10.36.010 (A) of the Code is hereby amended by deleting the second paragraph in its entirety and replacing it with the following language: "Parking meter rates shall be set at \$3.00 per hour for on-street parking and \$5.00 per hour for parking in beach lots (Lots A, B, and C). The hours of operation for meters throughout the City shall be 10:00 a.m. to 2:00 a.m."

**SECTION 3.** California Environmental Quality Act ("CEQA"). The City Council finds that this Ordinance is not subject to CEQA pursuant to Section 15061 (b)(3) (it can be seen with certainty that there is no possibility that the activity contemplated by this Ordinance may have a significant effect on the environment) and Section 15273 (CEQA does not

apply to modification of fees by public agencies for meeting operating expenses or financial needs).

**SECTION 4. Certification.** The City Clerk is directed to certify the passage and adoption of this Ordinance; cause it to be entered into the City's book of original ordinances; make a note of the passage and adoption in the records of this meeting; and, within fifteen (15) days after the passage and adoption of this Ordinance, cause it to be published or posted in accordance with California law.

**SECTION 5. Effective Date.** This Ordinance shall take effect thirty (30) days after its passage and adoption pursuant to California Government Code section 36937.
