In practice, the Commission can be a useful means for the City Council to get an additional "set of eyes" on CIP and other projects across the development lifecycle from proposal to construction and cost oversight. These are responsibilities I take seriously, and have the requisite experience to carry out. 	U.S. Food and Drug Administration (FDA) — Congressional Affairs Specialist (2020-2022) — In this role, I led FDA's engagement with Congress on COVID-19 vaccine development and regulation, emergency appropriations needs for COVID-19, drug manufacturing inspections, and other high-profile public health issues. — Relevance to the Public Works Commission: I formulated a report to Congress on the state of an aging FDA laboratory with qualitative and quantitative information on the costs and impact of renovating the lab, relocating the lab, or closing the lab. The experience I gained in this role will be useful in the ongoing assessment of options available to the City Council to address Hermosa's aging civic facilities.		
	Megafire Action — National Policy Director (current role) — I am currently the lead policy strategist for a non-profit dedicated to ending the wildfire crisis. — Relevance to the Public Works Commission: my work involves coalition building with fire professionals, unions, foresters, environmental NGOs, and both Democratic and Republican Members of Congress to enact effective wildfire policy. My experience working with diverse stakeholders in pursuit of common goals will be helpful as a Commissioner where collaboration with the City Council, residents, and city staff is key to successful public works projects.		
	Harvard Business School — Masters in Business Administration (2024) — In my MBA program I received strong training in financial analysis, budgeting, and resource allocation. Many of my courses focused on how to make data-driven, prioritized investment decisions. — Relevance to the Public Works Commission: this training will be helpful in evaluating the financial feasibility of public works projects and ensuring fiscal responsibility in city investments. Assessing technical and financial data on CIP projects, collecting public input and City Council direction, and making informed recommendations are essential functions of the Public Works Commission and my education has prepared me well to fulfill those responsibilities.
