## APPROVAL OF A RESOLUTION AUTHORIZING EXAMINATION OF SALES AND USE TAX RECORDS

(Administrative Services Director Brandon Walker)

#### **Recommended Action:**

Staff recommends City Council adopt a resolution of the City Council of the City of Hermosa Beach, California authorizing examination of sales and use tax records (Attachment 1).

### **Executive Summary:**

Due to recent staffing changes, the City needs to update its designated officials list with the California Department of Tax and Fee Administration. Staff recommends adoption of the proposed resolution to update its list of designated officials authorized to examine the City's sales and use tax records to include the newly created title of Administrative Services Director.

#### Background:

Section 7056 of the State of California Revenue and Taxation code specifically limits the disclosure of confidential taxpayer information contained in the records of the State Board of Equalization. The California Department of Tax and Fee Administration (CDTFA), the agency charged with assessing and collecting sales and use tax in the state of California, requires governing bodies to establish a resolution authorizing examination of sales and use tax records to designated officials. At its March 28, 1989 meeting, City Council adopted Resolution No. 89-5248 (Attachment 2) authorizing access to sales and use tax records.

#### Discussion:

In its ongoing efforts to improve efficiency and better serve its residents and visitors, the City created the Administrative Services Department through the Fiscal Year 2024–25 budget, by merging the former departments of Finance and Human Resources. Thus, the new director of this department—the Administrative Services Director—is now

responsible for, among other things, the duties and responsibilities of overseeing the finance, personnel, and risk management functions of the City.

The CDTFA requires City Council establish a resolution to authorize the new Administrative Services Director department title to examine the City of Hermosa Beach sales and use tax records.
