# CONSIDERATION TO REMOVE THE UPDATE OF TEMPORARY MINOR SPECIAL EVENT REGULATIONS FROM THE COMPREHENSIVE ZONING CODE UPDATE

## **Recommended Action:**

Staff recommend City Council direct staff to update the temporary minor special event regulations separate and apart from the comprehensive zoning code update.

## Executive Summary:

At its October 22, 2024, City Council meeting, Mayor Pro Tem Saemann requested, and Mayor Francois and Councilmember Detoy supported, adding a consent item to the next City Council meeting agenda directing staff to proceed with a zone text amendment addressing temporary minor special events separate from the comprehensive zoning code update.

## Background

At its March 12, 2024, City Council Meeting, the City Council received a presentation on the City's current regulations pertaining to temporary minor special events on private property. At that time City Council directed staff to proceed with the update as a part of the comprehensive zoning code update.

# Past Board, Commission, and Council Actions

## Discussion:

At its October 22, 2024 meeting, City Council received public comments requesting the temporary minor special event regulations be removed from the comprehensive zoning code update due to the prolonged timeline in completing the comprehensive update. In response, City Council requested the item be placed on the consent agenda to provide formal direction to staff to update Hermosa Beach Municipal Code Section 17.42.150-

Temporary Minor Special Events separately and ahead of the comprehensive zoning code update.
